The petition was filed to ask the Judge to allow the ballots from the last election to be counted, even though we did not reach quorum. The hearing date was postponed to Monday, June 22, 2015 at 3:00 pm in Department 2 located at 445 Pine Street, in Red Bluff.

Members are welcome to attend. We will report the courts findings and hold a meeting to count the ballots, if the Judge allows.

The 2015 Annual Board Election is scheduled for August 1st at 10am. Included with this newsletter you will find a Candidate Solicitation Notice. Two Board Member seats are up this year, Juan Caravez and Janice Menzies, pending the outcome of the petition hearing. If the Judge allows for the ballots to be counted from the last election the two elected directors with the lowest amount of votes will be up for election in place of Juan Caravez and Janice Menzies.

We are hoping that many qualified candidates will run in this year's election. The Close of Nominations and Record Date (day your assessments must be paid current) is June 15th. Keep an eye out for notices for meet the candidates night!

Now more than ever, we need your votes. As you can see, we cannot have an election without the required minimum amount of returned ballots. So make sure your assessments are paid and be sure to vote!
